To all who supported our neighbors,

Horizon House was established 30 years ago out of the need for a daytime multi-service agency that could coordinate the many services offered to homeless individuals in our city.

30 years later, we stand here today as a leader in fulfilling that need.

We want to express our gratitude for all the ways that you partner in our mission. Thanks to the support of nearly 1,000 donors and 660 volunteers, Horizon House served 4,949 individuals in 2018, an increase of 46% from 2016. The growing need for services, employment and housing continues, but with your help, 112 individuals secured employment above minimum wage and 120 people were placed in permanent supportive housing in 2018.

With your help, we implemented our full continuum of services as part of our strategic plan:

- Providing HELP: meeting neighbors where they are and inviting them to engage in services
- Inspiring HOPE: offering integrated, comprehensive services to overcome barriers and restore hope
- Finding HOME: meeting the goal of stability and long-term self-sufficiency for each neighbor

Major highlights from 2018 include:

- Horizon House celebrated its 30th anniversary with an open house and a brand new fundraising event, the Hope is on the Horizon breakfast, which raised over \$150,000 in critical funds for our mission.
- Program manager Melissa Burgess was named one of United Way's 100 Heroes to honor its 100th anniversary.
- Our housing team provided supportive services for 52 of the first 100 households to receive housing subsidies through the city's new supportive housing initiative, with the first neighbor housed on April 27, 2018.
- New employment services program RISE (Reaching Independence through Self-Sufficiency and Employment)
 was launched with a median pay of \$10 per hour and collaborated with nearly 50 community partners.
- Mayor Joe Hogsett and city's senior strategy director for homelessness shadowed the street outreach team.

2018 was an exceptional year and we could not have done it without you. We hope that you will celebrate with us as you review the annual report and see the improvements you've made in the lives of people in our community. We cannot thank you enough and invite you to keep supporting this work as the need continues to grow.






